Miniature Horse Club of Great Britain STALLION BREEDING REPORT



Stallion breeding reports shall be submitted to the MHCGB office by December 1st of each breeding year. An administration fee of £5.00 per stallion must be submitted with the report.

Late filing fee of £10 for reports received after 1st December.

If a stallion is co-owned, signatures of all owners are required to sign the stallion report.

If a breeding stallion dies during any current breeding year, his stallion report is due within thirty days following his death.

COMPLETING A STALLION BREEDING REPORT

- 1.** Submit a separate report on each stallion each year. Ensure to state the full registered name of the stallion and the MHCGB Registration Number.
 - The report should include all mares exposed to the stallion during the calendar year, listing their full registered name and MHCGB Registration Number
 - The report should include all mares serviced whether owned by the owner of the stallion or owned by other parties.
- 2.** The owner of the stallion will require a copy of each mare's registration details in order to facilitate completion of this form. Ensure that the last recorded owner of the mare is the person who contracts the breeding.
- 3.** Ensure you indicate the method of breeding:
 - ☐ – Artificial Insemination
 - ☐ – Hand
 - ☐ – Pasture
 - ☐ – Transported Semen
 - ☐ – Embryo Transfer
- 4.** Give exact date(s) exposed. If more than one service is given to a mare, state all dates. If hand bred or AI, state the exact day(s). If pasture exposed, give date the mare was turned into the pasture and the date she was taken out of the pasture. Do not combine two years.
- 5.** Sale of a Stallion, within thirty (30) days after a stallion is sold, the previous owner or registered agent, must file a stallion breeding report.
- 6.** After a mare has been exposed or bred to one stallion, at least 42 days must elapse before exposing the mare to a different stallion.
